<p>Registration/Rules Meeting</p> <p><u>Location:</u> Wave Point Marina & Resort 3600 County Road CC Sturgeon Bay, WI 54235 920-824-5440</p> <p><u>Date:</u> Friday, May 11, 2018</p> <p><u>Registration Times:</u> 5:00 p.m. – Registration Opens 6:00 p.m. – Registration Closes. 6:15 p.m. – Mandatory rules briefing begins. At least one (1) team member <u>MUST</u> attend.</p> <p>All anglers must be off the water by 4:00 p.m. on the day of the rules meeting.</p>	<p>Launch/Weigh-In</p> <p><u>Location:</u> Wave Point Marina & Resort 3600 County Road CC Sturgeon Bay, WI 54235 920-824-5440</p> <p>Take-off will begin at 6:00 a.m. or first safe light.</p> <p>First flight due in at 3:00 p.m.</p> <p>Sunrise 05/11/18 – 5:24 a.m.</p>	<p>Required Safety Equipment</p> <p>It is the responsibility of all anglers to have required state and federal safety equipment on board.</p> <p>At time of inspection each morning, be prepared to display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch.</p> <p>Inspection will be held during lineup for takeoff. Live wells must be empty.</p> <p>Keep marine band radios on Channel 72 for tournament information and use Channel 16 for emergencies.</p>
<p>Fish Limits</p> <p>Large and smallmouth Bass 14 inches and over.</p> <p>Teams are allowed to weigh a limit of five (5) fish per team.</p> <p>Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. An 8 ounce deduction will be made for each fish presented to the bump master for weighing that is determined to be non-releasable.</p>	<p>Site Hosts</p> <p>Paula Jones Wave Point Marina & Resort 3600 County Road CC Sturgeon Bay, WI 54235 920-824-5440</p> <p>Host Hotel</p> <p>Wave Point Marina & Resort 3600 County Road CC Sturgeon Bay, WI 54235 920-824-5440</p>	<p>Boundaries</p> <p>Fishing will be restricted to within 5 miles of the Door County shoreline with the southern boundary being a line running from Brown County line (N44*40'39.6510", W-87*59'5004") to the Kewaunee County line (N44*40'36.8898", W- 87*44'8026") and the boundary being Gills Rock (N45*17'38.9724", W-87*1'23.0376") again, maintaining the 5 mile limit. Waters within 1.5 miles of Chambers Island may be fished. No fishing permitted east of buoys #5 & #6 at the US Coast Guard Station located toward Lake Michigan from Sturgeon Bay. There will be no fishing allowed in Lake Michigan. Any waters within these boundaries posted "off limits" or "no fishing" by state or federal agencies will be off limit. Any live release areas established by the Tournament Director will be off limits. That as well as any additional off limits will be announced at the pre-tournament briefing. Only that water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. All local, state and federal regulations apply.</p>
